

國立中興大學國際頂尖指標型期刊論文刊登費補助辦法

Guidelines for Subsidizing Publication Fees of Articles in International Top-Tier Journals at National Chung Hsing University.

113. 5. 15 第 463 次行政會議訂定

Established by the 463rd Administrative Meeting on May 15, 2024.

第一條 為鼓勵本校教師積極發表論文於國際傑出研究期刊，提升本校學術能見度，特訂定「國立中興大學國際頂尖指標型期刊論文刊登費補助辦法」（以下簡稱本辦法）。

Article 1

In order to encourage faculty members of the University to actively publish papers in internationally outstanding research journals and enhance the academic visibility of the University, the "Guidelines for Subsidizing Publication Fees of Articles in International Top-Tier Journals at National Chung Hsing University" (hereinafter referred to as the "Guidelines") are hereby established.

第二條 申請對象：本校編制內專任教師。

Article 2

Eligible Applicants: Full-time faculty members of the University.

第三條 經費來源：

- 一、本校年度建教合作計畫結餘款或校務基金自籌收入。
- 二、醫學院依校級「教學研究合作協議書」聘任之人員所需經費得由該人員所屬教學醫院支應。

Article 3

Funding Sources:

1. The annual surplus of the University's industry-academia cooperation plan or self-raised funds from the University's administrative budget.
2. For faculty members appointed by the College of Medicine in accordance with the University's "Teaching and Research Cooperation Agreement," the required funding may be covered by the teaching hospital to which the faculty member is affiliated.

第四條 申請條件及補助方式：

- 一、全額補助：一年內累計 2 次(含)以上刊登於國際傑出期刊(即論文期刊影響係數(IF)Impact Factor \geq 15 之期刊),且發表在 Journal Citation Reports(JCR)資料庫。累計 2 次(含)以上之採計時間係以第一篇論文正式刊登後起算一年。累計期間內論文刊登或被接受時之期刊影響係數達到補助標準者,第 2 篇(含)以上均予補助。
- 二、論文類型限補助「原著論文(Original Article)」及「綜合評論(Review Article)」。
- 三、申請者須為論文之第一作者(First Author)或通訊作者(Corresponding Author)。
- 四、申請者之作者機構須為本校名稱(國立中興大學/National Chung Hsing University),以列第一單位者優先補助。
- 五、不補助 JCR 最近一期公告之警告期刊。
- 六、論文刊登費不得於不同單位重複申請補助。

Article 4

Application Conditions and Subsidy Methods:

1. Full Subsidy: If the applicant has published two or more papers (within one year) in internationally outstanding journals (i.e., journals with an Impact Factor (IF) \geq 15) and indexed in the Journal Citation Reports (JCR) database, the second and subsequent papers will be subsidized. The one-year period is counted from the official publication date of the first paper. For papers published or accepted during this period, if the journal's Impact Factor meets the subsidy standard, the second (or subsequent) papers will be eligible for full subsidy.
2. The types of papers eligible for subsidy are limited to "Original Articles" and "Review Articles."
3. The applicant must be the first author or corresponding author of the paper.
4. The applicant's institutional affiliation must be National Chung Hsing University (National Chung Hsing University/National Chung Hsing University), with preference given to those who list the University as the first affiliation.
5. Subsidies will not be provided for journals listed in the most recent JCR warning list.
6. The publication fees cannot be subsidized by multiple units.

第五條 申請方式及審查程序：

- 一、申請人須檢附申請表、論文被期刊接受通知函、論文全文、出版社收取文章處理費(Article Processing Charge)之發票(Invoice)、付款證明等文件向研究發展處學術發展組提出申請。
- 二、審查會議：由研究發展處學術發展組於每季(三月、六月、九月、十二月)召開學術經費補助審查會議進行審議。

Article 5

Application Process and Review Procedure:

1. Applicants must submit an application form, an acceptance letter from the journal, the full text of the paper, the invoice for the Article Processing Charge (APC), and proof of payment to the Academic Development Team of the Research and Development Office.
2. Review Meeting: The Academic Development Team of the Research and Development Office will hold academic funding review meetings quarterly (in March, June, September, and December) to conduct the review.

第六條 獲補助之論文如經確立有違反學術倫理之情事，撤銷其補助，並追回補助金。

Article 6

If a subsidized paper is found to have violated academic ethics, the subsidy will be revoked, and the funding will be reclaimed.

第七條 本辦法經行政會議通過後實施，修正時亦同。

Article 7

These Guidelines shall be implemented upon approval by the Administrative Meeting and shall apply to any amendments.
